### SIERRA LEONE'S GOAL FOR CIVIL REGISTRATION & IDENTITY

With a population of 7.5 mil (2021 mid term census data),

Management System that serves the needs of the

Citizens and non-Citizen residents" in Sierra Leone."



### IDENTITY FOR SERVICE DELIVERY IN SIERRA LEONE


- Since 2017, NCRA positioned itself at the center of foundational Identity Services for all sectors
- Engaged Stakeholders as partners on the importance and use of Digital identity
- Collaborated with MDAs and private sector to understand sector needs
- Made Civil Registration free and accessible to both citizens & resident non-citizens
- Made NIN mandatory to accessing Public Sector services (ITAS, NASSIT, SLRSA etc.)

When usage surges, identity becomes more valuable, and enrolment increases.

Today, Identity is at the central of service delivery in Sierra Leone.



# SIERRA LEONE'S IDENTITY ASSETS





- Less than 7% had ID Card before 2016
- Mass Civil & Voter Registration led to 70% registration in 2016/2017
- Coverage up to 85% in 2020/2021
- Up to 90% registration in Q1 of 2023
- ❖ About 2.5 million children registered
- Multipurpose Biometrics ID Cards for Citizens and Non -Citizen residents
- Registration is decentralized with fixed and mobile registration facilities
- Biometrics Mobile Registration Kits
- Biometrics and Biographic data



# REGISTRATION COVERAGE IN SIERRA LEONE (7.5 MILLION POPULATION)

# INTEGRATED CRVS & ID MANAGEMENT IN SIERRA LEONE

Sierra Leone implements Integrated Civil Registration Vital Statistics & ID Management System to serve as one-stop-shop for all Civil Registration & ID Management services.

- Civil Registration
- Vital Events/Statistics Births,
  Deaths, Marriages, Divorce, Adoption,
  etc...
- Population Register
- Identity Management

- Serves as single source of truth

# PRINCIPLE OF DATA SHARING AND INTEROPERABILITY

# Single RegistrationMultiple Uses

\$ 8 P

"Registration Data"

Data is shared with and used by multiple stakeholders/Institutions for various services

Identity Records - shared with MDAs and other Institutions saves cost, time and assures reliability and consistency of data on the population of Sierra Leone.

The NCRA is mandated by law to account for the legal identity of all residents (citizens and foreign residents) in the country.

"Consent"

Data Subject gives consent before verification/data sharing for privacy and data protection



# THE NIN – NATIONAL IDENTIFICATION NUMBER

- For each record, a unique identifier is generated and assigned. This is known as the **National Identification Number (NIN)**
- NIN is a household name in Sierra Leone, and a critical tool for interoperability
- NIN is mandatory for every resident in Sierra Leone including children and foreign nationals
- NIN links residents to their identity information
- Over 90% have NIN in Sierra Leone from birth to death single assignment
- NIN helps residents to access both public and private sector services



# ISSUANCE OF SECURE IDENTITY DOCUMENTS/CREDENTIAL

From Registration to storing of identity data, varied security protocols are issued.



**Biometric National Identity Card** – For Sierra Leonean Nationals



**ECOWAS ID Card** (Biometric based and ECOWAS Compliant) – Issued on demand to ECOWAS Citizens



Non - National Biometric ID Card – Issued to other Nationals resident in Sierra Leone.



**Secured Identity Certificates** – Births, Deaths, Marriages, Divorce, Adoption etc...



### **USE CASES**

Sierra Leone has a growing Identity Ecosystem with various levels of commitments and increased collaboration

#### FOR INDIVIDUALS

- ❖ To prove their identity to access services
- ♦ (No NIN, No Service)

#### FOR BUSINESSES

- To fulfil KYC & regulatory compliance
- For effective service delivery

#### FOR GOVERNMENT

- To plan for developmental interventions
- For resources mobilization and distribution
- For effective and inclusive service delivery


#### FOR NGOs/Dev Partners

### **IDENTITY VERIFICATION & AUTHENTICATION**

- > Services are linked to the NIN
- Centralized ID Verification System
- Verification by API or Portal
- It is read-only
- Corrections/Updates done at NCRA and reflected across
- It is transparent and easier to do
- Increases access to services for the populace





### **IDENTITY FOR FINANCIAL INCLUSION IN SIERRA LEONE**

#### PRE- NIN

Inline with the Sierra Leone's Financial Inclusion Strategy, the Central Bank of Sierra Leone implemented the following;

- ❖ For the purpose of account opening, potential customers are required to **provide proof of identity** to meet **the Know Your Customer (KYC)** requirements
- \* Multiple ID's: Customers are required to provide any of the following ID documents: Passport, Drivers License, Social Security or old National Identity Card.
- ❖ Tiered-KYC: For potential customers in the villages and was developed to allow everyone to have access to financial services even without an ID Card

There is no unique ID to identify customers | Makes KYC difficult | Credit Reporting impossible



# ID USES – FINANCIAL INCLUSION IN SIERRA LEONE, CENTRAL BANK

Identity Verification and eKYC

- The National Civil Registration Authority (NCRA) and the Financial institutions signed an MOU for Identity Verification and Authentication for eKYC
- ❖ The pilot phase began with commercial banks integrating their systems with the NCRA's ID Systems
- ❖ Banks are connected to the NCRA's central ID Verification System to validate the NIN (read Only)
- ❖ NCRA's ID Verification Platform is consent-driven with Biometrics or OTP for consents of customers before verification
- Customers are given a time frame to give their National Identity Number (NIN) to their banks.
- ❖ ID Verification for eKYC will be rolled out to non-banks and foreign exchange bureaus.
